Annual Activities Report

The South Zone Cultural Centre at Thanjavur, Tamil Nadu established as a Society under the Ministry of Culture, Government of India, came into existence on 31st January 1986 with the objective to integrate people of India through Culture, Art and Heritage. The Centre has jurisdiction over the states of Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu and Union Territories Andaman and Nicobar Islands, Lakshadweep and Puducherry.

During the Year **2019-20** the South Zone Cultural Centre, Thanjavur has arranged **177** programmes. **12272** artistes from various parts of the country have been paid for their participation in various programmes conducted during the year. These programmes could be conducted successfully with the active participation and support of each Member State. Some of the programmes organised are highlighted below:

INDEPENDENT AUDITOR'S REPORT

TO THE MEMBERS OF SOUTH ZONE CULTURAL CENTRE

Opinion

We have audited the financial statements of M/s South Zone Cultural Centre, which comprise the Balance Sheet as at March 31, 2020, and the Income and Expenditure Statement and the Receipts and Payments statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements of the entity are prepared, in all material respects, in accordance with Tamil Nadu Societies Registration Act, 1975, subject to the following :

- (a) The payment of Gratuity Act is applicable to the Centre and it is obligatory to pay gratuity on to the zonal staff who have put in 5 year of continuous service at the time of retirement/ resignation or death. In respect of post retirement benefit viz. gratuity and Leave encashment benefits, as per Accounting Standard 15 issued by the Institute of Chartered Accountants of India, the centre should make provision on actuarial basis every year towards liability for future payment of gratuity/Leave encashment. However, the Centre has not made any provision towards it's liability with respect to Gratuity/Leave encashment benefits payable to it's employees. Accordingly, we are unable to comment on the adequacy of provisions, which may have impact on the excess of Income over Expenditure for the year ending 31.03.2020.
- (b) Confirmation on outstanding debit balances as at 31.03.2020, as detailed below, has not been made available :
 - a) Advances recoverable (under 'Current Assets') - Rs. 66,05,905/-
 - b) Shilparamam - Rs. 72,56,286/-
 - c) Advances receivable - FOI Combodia - Rs. 1,73,171/-.

Provision, if any required, in respect of the above could not be assessed at this stage as also the impact of the same in the Income and Expenditure account for the year ending 31.03.2020.

Basis for Opinion

We conducted our audit in accordance with Standards on Auditing (SAs). Our responsibilities under those Standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the entity in accordance with the ethical requirements that are relevant to our audit of the financial statements, and we have fulfilled our other responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and those Charged with Governance for the Financial Statements

Management is responsible for the preparation of the financial statements in accordance with Tamil Nadu Societies Registration Act, 1975 and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the South Zone Cultural Centre, Thanjavur for the year ended 31 March 2020.

We have audited the attached Balance Sheet of the South Zone Cultural Centre, Thanjavur as at 31 March 2020, Income & Expenditure Account and Receipts & Payments Account for the year ended on that date, under Section 20(1) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971. The audit has been entrusted for the period upto 2024-25. These financial statements are the responsibility of the Authority's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the law, Rules & Regulations (Propriety and Regularity) and efficiency-cum performance aspects, etc., if any, are reported through Inspection Report/ CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statement. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4 Based on our audit, we report that:

- i We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
- ii The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format approved by the Ministry of Finance.
- iii In our opinion, proper books of accounts and other relevant records have been maintained by the South Zone Cultural Centre, Thanjavur as required in the rules and regulations of the Institute, in so far as it appears from our examination of such books.

iv We further report that:

A. Balance Sheet

**1. Schdule-6-Current Assets, Loans, Advances Etc,
B. Loans, Advances, and Other Assets- ₹5.21 crore**

Prepayments towards Program advance of ₹0.66 crore was pending adjustment, although programs had been conducted resulting in understatement of deficit

**2. Assets - Sch-6 – A – Current Assets – ₹7.20 crore - 3. Bank Balances: -
a) with Scheduled Banks - ₹3.74 crore**

- 1) Difference of ₹0.06 crore between Cash at Bank as per Balance Sheet and as per Cash Book was not reconciled.
- 2) Closing balance as on 31.03.2020 in Indian Bank Plan Account, as per Current Asset Schedule -6 was ₹2.21 crore, whereas the balance considered in Bank Reconciliation Statement was ₹2.31 crore. The differential amount of ₹0.10 crore was not reconciled

B. General

Provision for retirement benefits was not made on actuarial basis as per Accounting Standard-15.

C. Effect of Revision in Accounts

The accounts of the Institute were revised based on audit comments. As a result, Assets/Liabilities increased by ₹1.21crore and the Deficit decreased by ₹0.15 crore.

D. Grants in aid

Out of grants-in-aid of ₹6.61 crore received during the year 2019-20, interest income of ₹2.50 crore and unspent balance of previous year of ₹1.35 crore totalling to ₹10.46 crore, the centre utilized a sum of ₹8.27 crore leaving a balance of ₹2.19 crore as unutilized grant as on 31 March 2020

F. Management Letter

Deficiencies which have not been included in the Audit Report have been brought to the notice of JIPMER Pondicherry through a management letter issued separately for remedial /corrective action.

v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report are in agreement with the books of accounts.

vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in the Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India.

1. Adequacy of Internal Audit System.

Internal Audit was conducted by a Chartered Accountant Firm for the year 2019-20.

2. Adequacy of Internal Control System:

- i. The Institute had not prepared an Accounting Manual. There was no Management Information System (MIS). Control Registers like Register of Assets, Expenditure Control Register/Budget Control Register, Advance register, TA/LTC Bill Register, Medical claim register, Stationary register, Register of contracts, Grant-in-Aid Register were not maintained.
- ii. Cash book of all accounts were not closed and not attested by the competent authority on 31.03.2020.
- iii. Due to non reconciliation of figures between Accounts and Utilisation Certificates, there was difference of ₹0.19 crore in sanctioned grant, ₹4.79 crore in Expenditure and ₹(-)3.27 crore in unspent balance. This shows lack of internal control.
- iv. Confirmation had not been received for an amount of ₹0.73 crore receivable from Shilparamam, Andhra Pradesh for more than fifteen years, which is due to lack of Internal Control System.

3. System of Physical verification of fixed assets.

Physical verification of fixed assets for the year 2019-20 was done.

4. System of Physical Verification of Inventory.

Physical verification of Inventory for the year 2019-20 was done.

5. Regularity in payment of statutory dues.

The Institute is regular in remittance of statutory dues.

Dear Sir,

Please refer to the Separate Audit Report on the Annual Accounts of Jawaharlal Institute of **South Zone Cultural Centre (SZCC), Thanjavur** for the year 2019-20 issued on 08.07.2021. I wish to bring the following defects noticed in accounting practices/procedures to your notice for remedial action.

1. Prior Period Expenditure of ₹47.40 lakh was included in Schedule – 12, as current year expenditure. This had resulted in overstatement of Current year expenditure and understatement of Prior period expenditure by ₹47.40 lakh.
2. Deposits (₹6.15 lakh) under Schedule 6 include deposits paid to TNEB to a tune of ₹1.46 lakh. However, as per TNEB portal, deposits made by South Zone Cultural Center was ₹2.50 lakh. Reconciliation was not made.
3. An amount of ₹15 lakh sanctioned by the Ministry of Culture to SZCC vide its letter dated 14.03.2019 was received and credited into the SZCC account on 02.04.2019 and an amount of ₹0.42 lakh towards Swatchh Action Plan, related to the period 2018-19 was received on 13.06.2019. Grant in aid of ₹15.42 lakh related to the previous year 2018-19 received during the current year, was included in the current year as grants received.
4. An amount of ₹70.83 lakh was exhibited as value of Sculptures against the certified value of ₹79.48 lakh. This had resulted in understatement of Fixed



Assets – Sculptures to the extent of ₹8.65 lakh and understatement of depreciation by ₹0.35 lakh.

5. An amount of ₹345.96 lakh was exhibited as Inventories for the year 2019-20, although the committee of experts had certified the value of assets as ₹342.58 lakh - on 31.03.2020 and as per Register of Inventories, it was ₹362.35 lakh.
