## Annual Activities Report 2018 – 2019 South Zone Cultural Centre, Thanjavur

The South Zone Cultural Centre at Thanjavur, Tamil Nadu established as a Society under the Ministry of Culture, Government of India, came into existence on 31st January 1986 with the objective to integrate people of India through Culture, Art and Heritage. The Centre has jurisdiction over the states of Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu and Union Territories Andaman and Nicobar Islands, Lakshadweep and Puducherry.

During the Year **2018-19** the South Zone Cultural Centre, Thanjavur has arranged **163** programmes. **10309** artistes from various parts of the country have been paid for their participation in various programmes conducted during the year. These programmes could be conducted successfully with the active participation and support of each Member State. Some of the programmes organised are highlighted below:-

**Opinion**

We have audited the financial statements of M/s South Zone Cultural Centre, which comprise the Balance Sheet as at March 31, 2019, and the Income and Expenditure Statement and the Receipts and Payments statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements of the entity are prepared, in all material respects, in accordance with Tamil Nadu Societies Registration Act, 1975, subject to the following:

- (a) The payment of Gratuity Act is applicable to the Centre and it is obligatory to pay gratuity on to the zonal staff who have put in 5 year of continuous service at the time of retirement/ resignation or death. In respect of post retirement benefit viz. gratuity and Leave encashment benefits, as per Accounting Standard 15 issued by the Institute of Chartered Accountants of India, the centre should make provision on actuarial basis every year towards liability for future payment of gratuity/Leave encashment. However, during the year provision of gratuity has been made to the tune of Rs.43.88 lakhs. Also, the Centre has not made any provision towards it's liability with respect to Leave encashment benefits payable to it's employees. Accordingly, we are unable to comment on the adequacy of provisions, which may have impact on the excess of Income over Expenditure for the year ending 31.03.2019.



**SCHEDULE -14****Significant Accounting Policies**

1. The accounts have been prepared under the Historical cost convention unless otherwise stated and on the accrual method of accounting.
2. Revenues in the form of grants from various institutions and Government agencies are recognized only to the extent of amount spent during the year and remaining unspent is shown as "Grants Unspent" under Current Liabilities. Accounting for Revenue Grants complies with the Accounting Standard 12 prescribed by ICAI.
3. a) Fixed Assets are stated at written down value for assets acquired upto 31.03.2018 except Freehold land and Artefacts.  
 b) Freehold Land, Artefacts and additions to Fixed Assets made during the year are CC stated at cost.  
 c) Depreciation is provided on Fixed Assets other than Artefacts at the rates provided in the Income tax Act 1961 wherever applicable. Depreciation on assets not put to use for full year is charged at half the normal rates of depreciation prescribed under the Income Tax Act. d) Depreciation on 'Artefacts' has been charged under "Straight Line Method" @ 4% on the year-end value, assuming the useful life of such sculptures as 25 years, regardless of the date of additions during the year.
4. Investments are stated at cost and interest accrued on the same has been considered up to the end of the financial year.
5. Inventories, held in the form of "Paintings", for acquisitions up to 31.03.2016 are valued as per the value assigned by the Expert Committee and for additions made thereafter, they are valued at cost as determined by the management from the relevant records/books of accounts.
6. Expenses identifiable against specific grants are allocated and accounted separately as per Accounting Standard 12 prescribed by ICAI.
7. Expenses not allocable to any specific grant has been accounted commonly and complies with Accounting Standard 12 prescribed by ICAI.
8. Expenses incurred relating to different festivals / programmes conducted in different states/locations constituting several revenue expenses are grouped and reflected in the Income & Expenditure account under the relevant head "Festival/Programmes" against each location, instead of grouping such on-going revenue expenses under their natural heads in the Income & Expenditure statement.

Reserves & Surplus includes “Capital Reserve” of Rs 169 lakhs representing the Tamilnadu Government Fund for Land - Rs. 154 lakhs, G.K.Moopanar MP Fund for Auditorium Furniture - Rs.5 lakhs and Thanjavur DRDA Modern Art Gallery Fund -Rs.10 lakhs.

**3) Earmarked funds - Schedule 3**

Earmarked funds of Rs.16,200/- pertaining to membership fees collected earlier and disclosed as 'Earmarked Funds' as at 31.03.2018 has been credited to Income and Expenditure account for the year ended 31.03.2019.

**4) Current liabilities & Provisions - Schedule 4**

- a) Current Liabilities of Rs.323.32 lakhs includes Rs. 53.94 lakhs on account of provisions made for various expenses. CCO
- b) Interest earned on Grant-in-aid amounting Rs. 26,20,446/- which is refundable to Government account as per the stipulations is shown separately under Current liabilities.
- c) During the year 2016-17, with regard to 'Rastriya Sanskrit Mahotsav', there was an excess expenditure for Rs.1,32,539/-. The centre had sent a reminder to the Ministry for the settlement of such claim. SZCC is waiting for the approval till date. The centre has not accounted for the said excess expenditure payable to the units as liability and also the equivalent amount for which the Centre has made a claim, pending with the Ministry.
- d) No provision has been made in respect of liability towards Leave encashment payable to employees and the same is accounted as and when the expenditure is incurred on retirement etc. of employees.



**5) Fixed Assets - Schedule 5**

- a) In the absence of adequate records to assess the correct value of cost of Fixed Assets acquired up to 31.03.2018 which are being carried forward in the books at WDV value (except Freehold land stated at cost) and the additions during the year being reflected at costs, the depreciation thereon has been computed separately in respect of both and the WDV of respective assets has been reflected accordingly. This has been done to ensure reflection of cost of at least Fixed Block added effective from 01.04.2018 at 'Cost instead of 'WDV' basis, whereas the assets acquired up to 31.03.2018 would be depreciated / written off during the residual life of the assets.
- b) Fixed Assets are stated at written down value, as stated above, after providing depreciation at the rate provided in the Income tax Act 1961.
- c) Artefacts, in the form of "Sculptures", were inventorised as of 31.03.2016 and the value of individual items was assigned by an Expert Committee. The useful life of sculptures has been estimated during the year on an overall basis by the Management to be 25 years. In respect of sculptures brought into books as of 31.03.2016, the residual useful life has been assumed to be 25 years by the Management, having regard to the physical conditions/ status of such sculptures and the value assigned by the Expert Committee has been accordingly reckoned as cost.

In respect of additions of such items during 2016-17, as against the actual cost of such items as identified by the management as per records/books of account amounting to Rs. 5,75,693/-, the same was brought to books on the basis of value assigned by artists amounting to Rs.6,11,000/-, thereby resulting in over valuation of such items to the extent of Rs.35,307/-. However, such excess valuation over the actual cost is adjusted in the books during the year ended 31.03.2019 (ie) by reducing the value of Artefacts to actual cost for the items relating to additions during 2016-17, by reversing the excess value over the cost recorded during the said year, amounting to Rs.35,307/- (6,11,000-5,75,693).

The depreciation has been charged on sculptures @ 4% per annum under 'Straight Line Method'.

The depreciation of Rs. 28,69,073/- charged to Income & Expenditure account in the current year includes Rs. 5,30,927/- towards arrears of depreciation charged in respect of items brought to books as of 31.03.2016 and also in respect of additions made during the year ended 31.03.2017.

#### 6) Investments - others-Schedule 6

Investments are carried at cost. Investment of Rs.3530 Lakhs has been made in scheduled banks and in Government of Tamil Nadu undertakings.

#### 7) Current Assets - Schedule 7

- a) Items held in the form of 'Paintings' were inventorised and the value of each item was also assigned by an Expert Committee as of 31.03.2016. Subsequent addition of paintings during the years ended 31.03.2017 and 31.03.2018 have also been added as per value assigned by the artists themselves.

In respect of paintings which were brought to books of account as of 31.03.2016, the individual cost could not be assessed with reasonable accuracy, as they were accumulated over a long period from inception. Accordingly, the value assigned by the expert Committee has been reckoned to be 'Cost, which is lower of estimated Market / Net Realizable Value. In respect of additions of such items during 2016-17 and 2017-18, instead of the actual cost of such items as identified by the



management as per records/books of account, the same was brought to books on the basis of estimated values assigned by artists resulting in over/under valuation of such items to the extent specified hereunder :

**Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the South Zone Cultural Centre, Thanjavur for the year ended 31 March 2019.**

We have audited the attached Balance Sheet of the South Zone Cultural Centre, Thanjavur as at 31 March 2019, Income & Expenditure Account and Receipts & Payments Account for the year ended on that date, under Section 20(1) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971. The audit has been entrusted for the period up to 2019-20. These financial statements are the responsibility of the Authority's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2 This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the law, Rules & Regulations (Propriety and Regularity) and efficiency-cum performance aspects, etc., if any, are reported through Inspection Report/ CAG's Audit Reports separately.

3 We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material mis-statements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statement. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4 Based on our audit, we report that:

- i We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
- ii The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format approved by the Ministry of Finance.
- iii In our opinion, proper books of accounts and other relevant records have been maintained by the South Zone Cultural Centre, Thanjavur as required in the rules and regulations of the Institute, in so far as it appears from our examination of such books subject to the comments mentioned below.

iv We further report that;

A. Effect of Revision in Accounts

The accounts of the Institute were revised based on audit comments. As a result, Assets/Liabilities were increased by Rs.91.56 Lakh and the surplus of Rs.32.33 lakh in Income and Expenditure Account had become deficit of Rs.2.41 Lakh.

B. Grants in aid

Out of grants-in-aid received for the current year of Rs.5.23 Crore and unspent balance of previous year of Rs.1.29 crore (total Rs.6.52 Crore), the centre utilized a sum of Rs.5.17 Crore leaving a balance of Rs.1.35 Crore.

v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report are in agreement with the books of accounts.

vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in the Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India.

b. In so far as it relates to Income & Expenditure Account of the deficit for the year ended on that date.

**Annexure****1 Adequacy of Internal Audit System.**

Internal Audit was conducted by a Chartered Accountant Firm for the year 2018-19.

**2 Adequacy of Internal Control System:**

The Institute had not prepared an accounting manual detailing the method of accounting for various revenue and capital expenses/incomes. There was no Management Information System (MIS) to regularly appraise the management of the details of expenses on programmes, pending advances, etc. For the advances and other receivables shown under current assets in financial statements, no confirmations of balances were obtained. In one instance, it was noticed that adjustment bill for program advance of 15.65 lakh was processed after 45 months from the date of receipt of bill. Some of the control registers like, Fixed Asset Register, Expenditure control Register, TA/LTC bill Register, Medical claim expenditure Register and Grants-in-aid Register were not maintained.

In view of the above, Internal Control System in the Institute is construed as inadequate.

**3 System of Physical verification of fixed assets.**

Physical verification of fixed assets for the year 2018-19 was done.

**4 System of Physical Verification of Inventory.**

Physical verification of inventory for the year 2018-19 was done.

**5 Regularity in payment of statutory dues.**

The Institute is regular in remittance of statutory dues.
