DEPARTMENTAL ENQUIRY REPORT AGAINST SHRI G MEENAKSHI NATHA PILLAI

Shri G Meekakshi Natha Pillai, Accounts Unit Officer, was suspended w.e.f 08.11.2023 for six serious charges such as fraud, violation of rules and gross misconduct. The Departmental Enquiry was conducted with Col. Raghunathan (Retd) as the Enquiry Officer. The Director of SZCC briefed before the Board of Governors the charges and the recommendation of the Enquiry Officer in his Report and reflected that the delinquent officer may be dismissed from the service in the best interest of the institution.

**Decision:** After a detailed discussion, the board authorized the Director, SZCC, the disciplinary authority, to take an appropriate decision as per rule and also to go for a CBI enquiry.

# AGENDA - XV

ANY OTHER ITEM WITH THE CONSENT OF THE CHAIR.

The Hon'ble Governor opined that the Centre should conduct painting exhibitions and generate revenue. The Director said the Centre has been doing so since the revaluation of artefacts and the last BoG meeting of the SZCC. The Hon'ble Governor suggested that painting exhibitions be held at Raj Bhavan while the SZCC conducts programs there during special occasions.

The Hon'ble Governor informed that as the country celebrates the 75th year of adoption of the Indian Constitution, new art choreographies in regional languages highlighting the preamble, spirit, and various aspects of our Constitution may be made and presented in various parts to increase the literacy and awareness of the Constitution among the general public.

Ms Asha Suresh Nair, Kerala, expressed her concern that her request to conduct a festival under the aegis of an NGO was not considered by the Director, SZCC, irrespective of the fact that she is a BoG member. The Director reflected that on the same day of receipt of the proposal, he sent a reply mail requesting further details about the logistics and the nature of support from the State Government departments mentioned in her proposal to place before the then ensuing Finance Committee, but there was no response.

The Joint Secretary (ZCC) informed the member that, as per norms, proposals from NGOs are to be routed through the Department of Culture of the State concerned with their recommendation. Ms Asha Suresh Nair also expressed her anguish at not being invited to the SZCC's programs in Kerala. The Director explained that all the information is provided on the Centre's website. The Hon'ble Governor and the Joint Secretary opined that the Centre may also send it to members by email.

The meeting ended with the consent of the Chair and the Director, SZCC, expressing Vote of Thanks to the Hon'ble Governor and all the members who attended the meeting.
