Vide Circular no. F.No.25-1/2024-ZCC dated 13th May, 2024 and E.mail dated 30th May, 2024 received from MoC, 10% of the total grant is to be ear-marked for the programmes of the Ministry of Culture.

The recommendations from Kerala — Support for Soorya National Theatre Festival Rs. 3,22,000/-, Swaralaya Dance & Music Festival Rs. 24,00,000/-, Sargalaya International Arts and Crafts Festival Rs. 12,00,000/- may be reviewed by the Kerala Department of Culture and resubmitted within a week adhering to the (above) guidelines and the SZCC director may take a call on it provided the ceiling budget is followed in the programming.

The Member States to forward NGO's request for sponsorship of Classical arts to the Sangeet Natak Akademi or the NGOs may apply for the Cultural Functions and Production Grant Scheme (CFPGS) of the Ministry and not to ZCCs.

Not approved the Proposal for Folk Arts Festival at Irinjalakuda, submitted by Ms Asha Suresh Nair, BoG Member of SZCC.

Member States coming under more than one ZCC, such as A,P, Telangana and Karnataka must ensure that their recommendation for support to NGOs should be submitted to only one ZCC, with a mentioning about it in the recommendation letter, to avoid duplication. The Member States may also ensure that such applications are not coming under the CFPGS of the Ministry of Culture.

Accordingly, the application of Parinthin Rashtreeya Nritya Sangeetha Mahotsava 2024 at Sagar, recommended by Karnataka Art & Culture Department to both SCZCC and SZCC may be considered by the SZCC and supported as per the above guidelines and subject to availability of funds.

1) Request by the representative from Tamil Nadu, Director Art & Culture, to meet the logistics too by SZCC in certain cases of programming.

Decision: Per norms the programs in association with Member States are on a cost-sharing basis, wth the ZCC meeting the artists' fee and travel and all other logistics including local travel by the Member State Concerned. Further, if the ZCC bear this cost too, it will reflect a shortage in the number of programmes and direct benefit to the artists. However, if exceptional cases up to 25% of the total cost may be met by the ZCC towards logistics by direct payment to the beneficiary.

2) Request by the representative from Puducherry, Director Art & Culture, for OCTAVE festival in Puducherry.

Decision: OCTAVE festival may be given in each Member States on a rotation basis. As in 2023 it was at Chennai and prior to that at Karnataka, the SZCC may take a call on it subject to availability of funds.

The Joint Secretary who chaired the meeting suggested all the Member States to document the programs and share the footage with the SZCC.

The meeting concluded with the Director, SZCC cum Member Secretary of the Executive Board, proposing the vote of thanks.
